1. Attendees and Apologies

2. Approval of Minutes

The minutes of the Committee meeting from 15th June 2023 were approved.

3. Club Manager Update

- a) The Club is now awarding physical certificates for the Monthly Winners, F₂F will be presented and online will be posted.
- b) F2F numbers continue to grow and Online is declining as forecasted.
- c) We have received notice about the Willis renovations, the builders expecting it to take 4-6 weeks, Committee agreed to plan on 6-8 Weeks. Mike and Mark to communicate to members.
- d) Beginner Lessons have commenced with increased numbers due to the marketing we have been doing. It was acknowledged that Fiona is doing a great job.

4. The Willis Renovation Plan

- a) The Willis will be closing on 11th Sep, in this time, we will get new flooring, both toilets off the main hall will be renovated and in use. Office will be refurbished, and the main divider will be replaced.
- b) After this time, we will talk to the Willis Management about the possibility of a lease.

5. Ted Chadwick rules

Rod updated the committee on IR laws that had changed and about more changes on the way. It was agreed that when the next changes came into effect The Club should engage an IR Consultant to review our compliance.

8. East Lindfield Lease renewal

Rod wanted officially to raise and agree the group to negotiate/handle the renewal of the East Lindfield licence agreement. It was agreed that Mark and Mike would own this as well as The Willis agreement.

- a. Jake updated the Committee on the NSWBA Merger Working Group and gauged the Committee's interest in being part of the discussion re:

 - e. Promotion and Advocacy of the game
